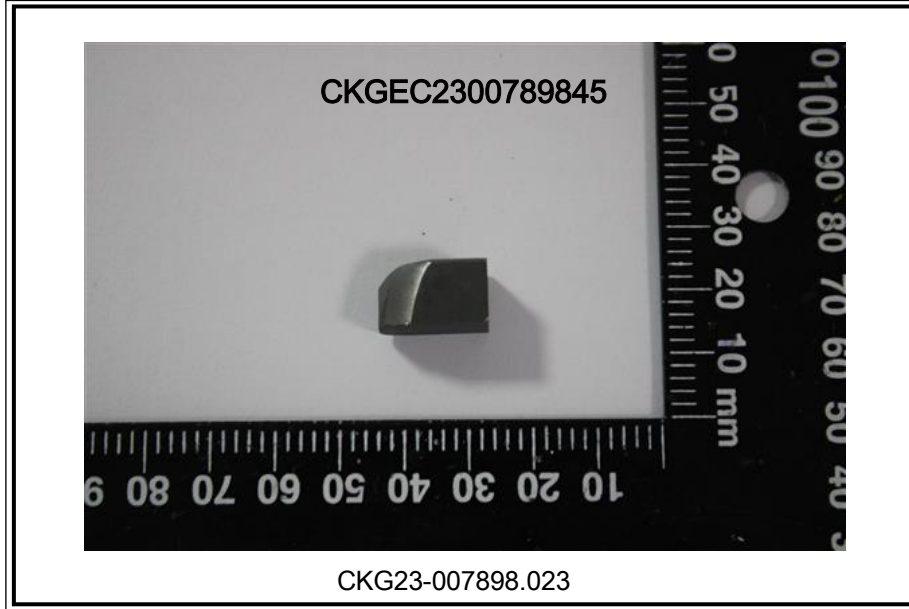
Phthalates Testing Flow Chart
